### Terms and Conditions of displaying as vehicle

1. Signing the declaration confirms you have read these conditions and agree to abide by them.
2. Access is available Friday from 19;00, Saturday until 09.45 and after 18;00, Sunday until 09;45 and after 18;00. Other times may cause manoeuvring and safety issues and delays displaying your vehicle.
3. Space is limited and no trading is allowed from your bus. Please book a sales stand in the designated sales area if you wish to trade at the event.
4. If you are a food or beverage bus please contact us for details as dedicated spaces have been allocated for such vehicles.
5. If over subscribed we may need to request buses that are more local to the event attend only one of the days to allow other buses to be displayed.
6. The organisers and the park owners accept no responsibility for damage to or loss of your vehicle or its contents while at, participating in and or travelling to or from the event.
7. All vehicle movements must comply with our method statement which will be published closer to the event date
8. For static display buses- It is essential that you hold a relevant insurance policy that includes public liability and the vehicle is entered as a static display and must not be started, driven or otherwise operated during the course of the rally.
9. Anyone driving your vehicles must hold the relevant driving licence.
10. For buses operating on the X70 route- Operational buses must have the correct insurance to cover road run vehicles and normal third party and public liability insurance and that any driver holds an appropriate driving licence and qualification.
11. Please provide documentary evidence of the above with this entry or at least two weeks before the event for items renewing before the event date.
12. Buses in service may have limited opportunity to be in the main display area given the limited manoeuvring room in the display area.
13. You must keep the area around your bus clear of items for safety and photographic reasons.
14. You may camp on your bus but generators are not allowed. Please make sure you keep valuables be out of sight and secured.
15. Some businesses on the park operate 24 hours a day and we must limit noise that may affect them or neighbours of the park.
16. Please bring sufficient refuse sacks for your waste. We encourage recycling. We will charge for clearing your rubbish if left behind.
17. Closing date - Entries for site bookings should be received no later than 1st May 2024. Late bookings may not be listed in the program.
18. Nothing is to be placed in front of your bus to allow unhindered photographic opportunities for visitors. Please leave your bonnet down (unless you are showing the engine to a visitor in which case please limit the time this takes) not withstanding a request for an open bonnet line up for photographing.
19. All participants must adhere to the Government's current guidelines on COVID 19 or any local guidelines set out by the local Council for COVID 19.
20. We reserve the right to add, delete or alter any conditions as we see fit prior to the event and will inform you by email of the changes.
